

Official Rules – United Power Sweepstakes for Adam's County Fair Tickets

These Official Rules ("rules") for the United Power Sweepstakes for Adam's County Fair Tickets ("sweepstakes") set forth the method of entry, method of selecting winners, the term, and other conditions for participation in the sweepstakes.

<u>Eligible Participants/Entrants</u>— This sweepstakes is open to persons who are at least eighteen years of age at the time of entry. To be eligible the member must complete one of the two methods of entry. Each household or business is limited to one entry during the term of this sweepstakes. Duplicate entries will be disregarded and will not increase the participant's odds of winning a prize.

<u>Methods of Entry</u> – In order to enter for a chance to win a prize, eligible participants must either (i) complete an entry at <u>www.unitedpower.com/fair-giveaway</u>; or (ii) submit an entry by mail including the entrant's name, address, phone number, and email address to: United Power, Attn: Adam's County Fair Tickets Sweepstakes, 500 Cooperative Way, Brighton, CO 80603. The method of entry does not change a participant's odds of winning a prize. Employees of United Power and their immediate family members are not eligible to enter.

<u>Term</u> – The period for entering this sweepstakes begins on July 1, 2024 at 12:01 AM and ends on July 22, 2024 at 11:59 PM. Entries must be received within this period or will be deemed void.

<u>Prizes</u> – There are four prize packages associated with this sweepstakes (each a "prize"). Each prize includes four (4) tickets the specified event, two (2) unlimited carnival arm bands, and a \$30 concessions gift card. Four (4) separate eligible participants will be selected ("winners") to receive one (1) of the four (4) prizes. Winners will be specifically selected for each of the prizes. No substitutions will be provided; tickets for each event may only be used at the specified event, on the associated date and at the specified time. Winners are not eligible for any cash prize equivalents. The events, dates, times, and estimated retail value for each prize are as follows:

- Demolition Derby and Fireworks (two prizes available) August 2, 2024 at 7:00 PM: \$155.00 (each)
- NSPA Truck Pull (one prize available) August 3, 2024 at 7:00 PM: \$155.00
- Dia d la Familia (one prize available) August 4, 2024 at 5:00 PM: \$155.00

Organizers of the Adams County Fair have provided United Power with the prizes in association with United Power's sponsorship commitments to the Adams Count Fair, Otherwise, the Adams County Fair and its organizers are not affiliated with this sweepstakes. The selection of winners and distribution of prizes is being run by United Power, Inc. located at 500 Cooperative Way, Brighton, CO 80603 ("United Power"). United Power may be contacted at the same address with any questions regarding this sweepstakes or rules.

No Purchase Necessary - No purchase or payment of any kind is necessary to enter or win this sweepstakes.

Selection of Winners — Entry does not guarantee the participant will win a prize. On or about July 23, 2024, United Power will randomly select four (4) potential winners from all entries. United Power reserves the right to verify that selected potential winners meet the conditions of an eligible participant. If any selected potential winner has not met the conditions set forth in these rules, United Power may select a new potential winner. Upon verification that the selected potential winners have all met the conditions set forth in these rules the winners will be contacted by phone or email within seven (7) days of the random selection and be provided with instructions for claiming their prize. If a winner fails to claim his or her prize by August 8, 2024, the prize will be forfeited and there will be no winner for the forfeited prize.

Odds of Winning – Odds of winning a prize depend on the number of participants in this sweepstakes. Each participant has an equal opportunity to win a prize. If there are 500 participants, odds of being selected as a winner



are 1 out of 500; provided that after each winner is selected, they are removed from the pool of eligible participants for the random selections for remaining prizes such that odds of winning the second prize are 1 out of 499, odds of winning the third prize are 1 out of 498 and odds of winning the fourth prize are 1 out of 497.

<u>Governing Law:</u> This sweepstakes is governed by the laws of Colorado and of the United States. SWEEPSTAKES VOID WHERE PROHIBITED BY LAW.

<u>Taxes</u> – Each winner is solely responsible for any and all applicable state and federal taxes on the prize awarded to them.
