

Official Rules – United Power Annual Meeting Sweepstakes

These Official Rules ("rules") for the United Power Annual Meeting Sweepstakes ("sweepstakes") set forth the method of entry, method of selecting winners, the term, and other conditions for participation in the sweepstakes.

<u>Eligible Participants/Entrants</u> – This sweepstakes is open to persons who are at least eighteen years of age at the time of entry. To be eligible the member must satisfy the method of entry stated below and must be present at the time of selection. Each household or business is limited to one entry during the term of this sweepstakes. Duplicate entries will be disregarded and will not increase the participant's odds of winning a prize.

<u>Selection of Winners</u> – Entry does not guarantee the participant will win a prize. United Power will randomly select potential winners from all entries after 6:30 pm on April 16, 2025. Selected potential winners must be present to win and claim their prize. United Power reserves the right to verify that selected potential winners meet the conditions of an eligible participant. If any selected potential winner has not met the conditions set forth in these rules, including identifying themselves within a reasonable amount of time, in United Power's sole discretion. United Power may select a new potential winner. If a winner refuses or otherwise fails to claim his or her prize United Power reserves the right to determine that the prize has been forfeited and there will be no winner for the forfeited prize.
